## 1.1 Obituaries

It is with sadness that the club records the passing this year of several members of our cricketing community:

#### **HUGH MILLER (Life Member and President)**

Hugh joined Howick in 1965 when it entered the ACA competition. He was at that time a member of the North Shore senior XI although he lived in Howick. He was a very good allrounder and an excellent left arm medium pacer.

Hugh tells us how he came to join Howick, "I had indicated to Clovis Bonner that the day Howick Cricket Club left City & Suburban I would leave North Shore and play for Howick. Sometime later I received a call from Clovis on a Monday night advising me to attend practice the next evening. Yes, they had changed. I was asked to attend the next committee meeting, where I was appointed ACA delegate."

Hugh quickly established himself as a key member of the first XI scoring 332 runs and taking 25 wickets in his first season. He had a glorious season in 1967-68 with 470 runs and two centuries to his name plus 29 wickets. He was also captain for several years.



Hugh served on the committee for fourteen years as ACA delegate and was Chairman 1969-70 to 1974-75. His involvement started before he actually played with negotiating our admission into the ACA senior B grade being part of his job. His work with ACA also eased our entry into premier Grade.

Hugh became a Life Member in 1974-75 upon stepping down and was immediately elevated to President. It's a long time ago now and we tend to forget people, but Hugh came along and turned out to be the right man at the right time. His contribution was vital as the club built on the solid foundations laid by previous committees. His experience was invaluable to the new committee members and enabled them to take the reins when he moved on.

#### **BETTY SHACKLEFORD (Vice Patron)**

Betty, along with her husband Owen, became involved with Howick Pakuranga cricket in the 1970's when their son Ian started in schoolboy cricket. They both followed Ian's progress right through his lengthy playing career.

Betty was always in the background and ended up helping in the financial side of the club's affairs in the 1980's and 1990's. It was a time when the club was undergoing many changes both on and off the field and her contribution was invaluable.

Betty was elected as Vice Patron in 2010 and remained in that position until her passing in 2024.

#### **ROLAND PHILLIPS (General Manager)**

Roland Phillips was General Manager for five years and not only did he carry out his duties efficiently, but he spent many extra hours going above and beyond his daily duties to support the club.

Along with his wife Pam, who worked in the office and also gave so much more than expected to the club, Roland had to deal with managing all aspects of the club at a difficult time. Roland and Pam settled in the district in 2002 and brought their two sons Glenn and Dale into the club as youngsters.



Both played for the club's premier men's team and achieved national and domestic playing honours. Additionally, their son-in-law Donovan Grobbelaar played over 100 games for Auckland, and their grandchildren who are currently playing at the club look set to go far in the game. Overall, it is clear that Roland and his family have made a fantastic contribution to the Howick Pakuranga Cricket Club.

#### **JOHN THIRKELL (President)**

John Thirkell joined Howick Pakuranga in 1976 and was an active member of the club for nearly twenty years. During that period, he played some premier cricket but more often was part of the second grade. He was an active social member playing in the Guiness World Record matches in the mid-1970's, managing to score a century in the 1977 attempt. He also went on the club's Asia Tour of 1984.

John acted as Club Captain in 1994-95 which was the club's most successful year up to that time and served as President in 1995-96. Shortly after that he moved to the Hawkes Bay but continued to play on the annual HPCC Senior Golf Tour.

#### **DAVID ANDERSON (Player)**

David Andersen (known to us as Taito) joined HPCC in 1978-79. He was a much-needed acquisition as it was only our third season in premier grade. He was a left arm medium pace bowler and a useful bat. He took 42 wickets at an average of 10.76 in his first season. He played first class cricket for both Auckland and Northern Districts.

After three seasons in the premiers, Taito captained the senior A side for five more seasons, with his experience proving invaluable in helping prepare our young cricketers for premier grade. David moved to Whakatane in his later years but remained a keen supporter of the club through Facebook.

# 2.0 Office Bearer Reports

#### 2.1 President's Report

The 2024/25 season will be remembered as a long hot summer, that provided the club with fantastic results both on and off the field.

As our club membership remained steady again, we saw our teams and players performing well across all levels. Most notably, Brooke Halliday and Molly Penfold who became T20 World Cup Champions with the NZ White Ferns, Ayaan Lambat who represented NZ at the U19 World Cup, Harmeet Singh played six-a-side for NZ in Hong Kong, Marama Downes with the NZ XI against Sri Lanka, and Lachlan Stackpole who made his first-class debut for Auckland. Retaining strong connections to these players is important as we focus on them developing a lifelong passion for the game and participation across all levels.

Off the field, strong governance and management are ensuring that the club is in a very healthy position. Financially we continue to get stronger every year, our facility is one of the best in the country and our volunteers are outstanding. Those volunteers are the backbone of the club and play a massive part in its success. As such, we thank them for everything they do and their commitment to HPCC.

Furthermore, a shout out to our Monday night Twilight players, and the energy and enthusiasm they bring to the club each week. They certainly put in plenty of effort on the field, and just as much in the clubrooms afterwards. And while some of the stories have been heard many times over, we enjoy having them as part of our cricketing community.

Finally, this is my final season as President of the club, and it is a role that I have been incredibly proud to have held for the past eight seasons. Through that time the club has grown remarkably, achieving outstanding results and showing others in Auckland Cricket how the game should be run. All our achievements have been a result of the amazing people that make up our community. Whether players, volunteers or staff, current members or those from the past, regardless of age or ability, their passion for the club is stronger than ever.

As such, thank you everyone, all the best for the future, and I will see you around the grounds again next summer.

#### 3.0 Club Reports

#### 3.1 Operations

Wow ... what an amazing summer we had at HPCC both on and off the field. We witnessed incredible achievements by our teams, players, volunteers and more. We reinforced our club as one of the strongest in the country and again showcased our amazing community.

The club and grounds were their usual centre of activity as we hosted regional and national events that showcased our capabilities in delivering high quality cricket. Highlights were the NZ National Over 50's tournament, NZ Māori Nationals, ACA District Boys U17's, and College Sport Girls Gillette Venus qualifiers. These events feature a diverse range of players and provides them with playing opportunities respective of their age, gender, culture and ability.



The need for greater diversity and inclusion within club cricket in Auckland is a growing priority for our game. With the local demographics changing in our area, we need to ensure that we can attract players from all backgrounds and provide pathways for them within the club.

Our annual end of season members survey showed that we are well on the way to achieving this at HPCC with 94% of members highlighting the inclusive community we have at the club. Having strong club values was a priority for members, who noted sportsmanship, respect, enjoyment, fun, fair play, and development for all as cornerstones of who we are. The overall survey showed a high satisfaction rating from members who are very supportive of the club, our philosophies and the delivery of our activities.



At the heart of HPCC is our membership which held strong in comparison to previous season. Many other Auckland cricket clubs noted declines in their membership, especially amongst junior players. Pressure on time and from other commitments are key reasons for this, while some clubs simply need to focus greater attention on their youngest members. At HPCC we understand the importance of delivering strong programmes within these age groups, as we aim to develop lifelong players and members. This is reflected in our Junior Guiding Principles which highlight the needs of young players and ensures that their experiences in the game are as positive as we can make them.

To support this, our coach development programmes are incredibly important. The efforts of our volunteer coaches are vital in creating positive experiences for players. As such, we continued to ensure that we gave priority to coach development during in the season and committed to our coaches getting access to training, resources and one-one support. Our Academy Development Manager spent time running sessions with all our junior coaches during the season, and we will continue this again next season. We will also

be aiming to run more structured training sessions along with workshops that enable our coaches to strengthen their specific skills.

Other than coaching, we also need to thank our volunteers who contribute to the club in so many other ways as it is getting harder to find people willing and able to give up their time each week. This is an issue not just at the club, but across the whole country. As such, we appreciate those who supported the club, teams and players through the season, and look forward to seeing you around the park again next summer.

Within our volunteer groups we should say an extra thank you to those who score games each week. The introduction of PlayHq by NZ Cricket has caused many issues and a great deal of frustration for those using it at grassroots level. This season the feedback on the platform was better, as continued changes are slowly making it more reliable and user friendly. Furthermore, as we started the season, we ran training sessions to ensure that our scorers are up to date with modifications and felt comfortable scoring on the weekend.



Along with cricket specific events we also hosted other more social activities around the club. Our annual Patrons Day, Golf Day and new Supporters Club events were all well attended, and it is great to see members past and present catching up. We have a fantastic facility at the club, and it is awesome to see it full when we have these events, along with our regular activities on Friday and Monday nights.

To ensure that our facility is well used and well maintained, we are seeing the growing need to find ways to utilise it across the whole year. While BBAFC leased the pavilion again last winter, this relationship is not likely to be long term as they are changing the way their club operates. As such, private functions are becoming important, and we saw multiple events at the club that fill up the venue but also add to the continuing ways that we can diversify our revenue streams.

Revenue, beyond membership fees, is getting harder to source and the rising cost of living in Auckland is placing pressure on the finances of our members. Additionally, we are seeing fewer grant funders operating in the area and limited opportunities to attract sponsors. Therefore, the club continues to focus on having diverse income streams and building reserves that will protect our long-term future. Factor into this the pavilion, that when booked out throughout the year provides a positive source of income, however, is also a growing expense for the club as forecasted maintenance costs are becoming significant.



For now, the facilities are in great condition, and we appreciate the support of those who have taken time to help with maintenance and tidy up work. This was particularly noted with the full renovation of the indoor training centre offices, bathroom, and viewing area following a major flood in post-season.

We also thank Auckland Council for their efforts over the past summer and the excellent work that was done on the fields throughout the season. The club is fortunate that we do not have to meet the costs of preparing up to five grass wickets each week, and as such our relationship with the Council remains vitally important. Not only in season, but once cricket was finished, they started a full renovation of the #1 playing field and all five grass wickets. Throughout the season we also had access to new practice nets at Howick Domain and saw considerable maintenance on the outdoor nets at LEP.



Having great training facilities across the region and available for all 12 months of the year, is important for our Academy programmes and the development of our players at all levels. This season we welcomed Adam Jones back to the club as our new Academy Development Manager, and he made an immediate and very positive impact on our young players. We saw increased support for our Summer Series and JT Sparling Series teams and looked at new ways to identify talented players for the future. These club-based tournaments have a growing importance given the Talent and Pathway restructure at Auckland Cricket which will see new regional tournaments replace the historical district tournaments.

As part of our wider junior programme this year we also held field days against Grafton and Cornwall and welcomed St Joesphs Cricket Club from Australia. We had several teams head to the Hawkes Bay Cricket Camps over January and will be looking for new ways to connect with other clubs outside Auckland in the future.

All these opportunities are helping the club to retain players and establish their long-term connection to the club. We are currently the largest youth club in Auckland, with more than double the number of U15 and U17 teams that are found at most other clubs. This is a significant result across both the boys' and girls' grades, as we build a base of players that will transition into senior cricket. Strong links with local colleges, intermediate and primary schools provide mutual support for cricket in the area, introducing new players to the game and giving others additional opportunities to play.



Finally, the season was a big success as we continued to strengthen across all areas of the club but also started to see the rewards of the hard work that has been undertaken in recent years. The club's membership is stable, we are financially strong, have fantastic volunteers, incredible facilities, and are looking good for a positive future.

While many cricket and sports clubs across the country are starting to struggle and their future's look grim, HPCC is leading the way in showing how clubs can grow in tough times. At the core of this is a fantastic cricket community that support each other and work together across all levels of the club. As such, we are incredibly grateful for the work of all our volunteers as well as the dedication shown by our club staff.

Planning is now underway for an even bigger season in 2025/26. We will look forward to everyone being part of this journey, and we can't wait to see you all back at the park.

## 4.0 Cricket Reports

#### 4.1 Senior Cricket

After a tough summer last season, the Premier Men's side worked hard throughout the winter and were fully prepared for a big start to the summer. Even the late withdrawal of last season's coach, Matt Blandford, who took up a new role with the Auckland Hearts, was not enough to disrupt that work and the side were off to a winning start right from round one.

The overall squad is still relatively young for cricket at this level, but as each season passes, we are seeing them grow stronger and their performances becoming more consistent. A key focus for the club is retaining and developing these players to ensure we become a dominant force for many seasons to come.

As always, the season started with the two-day competition and the side's first game, an outright win against Papatoetoe, set the tone for the remainder of the season. Dominant performances with both bat and ball, saw the side power through the competition unbeaten, with only a rain effected draw against Hibiscus Coast preventing a clean sweep. The outcome was the side finishing 18 points clear at the top of the table, securing the Tom Hellaby Cup and promotion earnina back to the competition for next season.



In the Richard Jones limited overs competition, the side completed the round robin unbeaten, finishing top of the table and earning a home semi-final against Birkenhead. However, though the sides white ball performances were a significant improvement on their relegation form last season, a tough day with the bat resulted in a semi-final loss and our campaign coming to an end.

The Premier Men's T20 competition was reduced to just three rounds this season, to allow for a longer mid-season break over Christmas. As such, for the top two teams in each pool to advance to the quarter finals, wins in all three games were always going to be essential. Our side picked up wins against AUCC and Ellerslie but lost a rain effect game against Papatoetoe thanks to Duckworth Lewis. That game also resulted in the Hellaby-Hunt Cup returning to the opposition. While the round robin ended with the top three teams all having two wins and a loss, net run rate proved to be our sides undoing as we finished third and missed the playoffs.

Standout performers this season were the Winn brothers, Liam with 1018 runs and a top score of 202, while David scored 931 runs at an average of 116. With the ball, Azza Lambat's 38 wickets and Selwin Sanjay's 34 wickets were the leading figures from a very young attack.

The Premier Reserve Men's team continues to be a development ground for some very talented young players to prepare themselves for higher level selection. This reinforces the importance of this side staying in the major sections of their grade, as long term this will continue to strengthen the pathway through to the premier team.

This season the team's red ball performances were significantly better than last summer, and thanks to new coach Le Shur Vermeulen, we see the side developing great consistency and a strong bond between players. The side finished the two-day competition in 4<sup>th</sup> place, though a couple of close results could have seen them finish higher.



Having won promotion back to the major Premier Reserve limited overs competition last season, this summer was always going to prove tough for the young side. With just two wins from seven games, the side were lucky to avoid the relegation spot and retained their place in the majors. An improvement will be needed for them to finish higher next summer. Staying with white ball and the side's T20 performances were stronger as they finished top of their pool in the round robin stages and advanced to a home semi-final against Cornwall. However, on the day, some very important lessons were learnt as they lost to a more experienced side who went on to win the competition.

Kavi Minhas had a great season with the bat scoring 647 runs including an excellent 102 against Eden Roskill. The ever-consistent Josh Kingdon picked up 32 wickets, and we watched with excitement as up and coming young fast bowlers Raphael Scordino and Willem Hewitson-Townley became regular members of the side.

The restructure of the third-grade competition resulted in our side being included in the top eight of the new Premier Three grade. This competition is much stronger than the previous version, and our side certainly struggled to find their feet. However, a couple of big early season losses were soon forgotten as newly recruited players fresh from college first XI cricket filled the side and changed its fortunes. A 4<sup>th</sup> place finish in the two-day competition was a great reflection of their later season form. A special individual performance must be noted with Ross Khurana's unbeaten 327 against Kumeu.

The limited overs competition showed the talent of the team and growing depth in our senior grades, as they narrowly missed a place in the final. Their T20 form was also solid, and again just missed the final after some very good performances.

Also restructured this season were the remaining two-day grades, who now play in the Championship. With eight teams per pool, HPCC were represented in the Championship Three pool, a similar level to the previous 7<sup>th</sup> grade. This new structure sees the teams playing fewer days of two-day cricket but adds in seven rounds of T20 along with seven rounds of limited overs.

Overall, the changes proved very popular with the players and our side performed well finishing the competition sixth overall. It should be noted that the leadership and comradery of this side was outstanding this season, as they came together to fundraise for team uniform, scoring tablet, and other activities. Their team culture set a high benchmark for all HPCC senior teams.



#### 4.2 Women's Cricket

It was a mixed season of results for the Premier Women's team who continue to be a victim of their own success. Strong player development in recent season is reflected in eight players having domestic contracts, and another eight representing either Auckland or Northern Districts at age group level. With these players constantly in and out of the squad due to other fixtures, regular Saturday selections for the Premier side prove to be quite difficult.

Regardless of this, the side was able to make the semi-finals in both the Prichard Cup (Limited Overs) and Pearl Dawson (T20) competitions, eventually finishing 4<sup>th</sup> in both. Under new coach Amberly Parr, a large number of young players were able to get exposure to this level of cricket, and we saw considerable growth in squad depth and ability. Performances highlights for the summer included Saachi Shahri's maiden HPCC hundred against Suburbs New-Lynn and Neena Woolalston's hattrick against Takapuna. Radhika Patel was again the sides lead run scorer as she continues to be one of the hardest hitting batters in the competition.



While the depth of our overall squad continues to grow, we opted again to run our Premier Development and Premier Reserve sides as composite teams with Auckland University. Both clubs have had a strong focus on developing our younger players over the past few seasons, and while we could each enter stand-alone teams, the combined teams enable us to select players at a level that suits their skill development.

The results for both teams were impressive, as the young squads finished 3<sup>rd</sup> and 2<sup>nd</sup> in their respective T20 and Limited Overs competitions.

Overall, our Premier Women's squad is growing by the season, and the continued development of young players is proving to be successful. As we retain these players long term, we will look forward to continued team success and individual selection to higher honours. We also say a massive thank you to the very dedicated band of parents and other family members who support these teams each week. They are a fun bunch to spend time with, energetically cheer on the teams and are always volunteering to help.

## 4.3 One Day, T20 and Twilight Cricket

During the summer, HPCC fielded two Saturday limited overs sides, one Presidents team and three Sunday T20 sides. Our preference to move away from closed shop teams entering these grades means our presence in them will remain limited. However, we are hoping that Auckland Cricket will review these competitions over time and find ways to offer better playing experiences for all players.

The One Day 4a side, which is the club's 5<sup>th</sup> selectable team, now have a solid core of players



which leads to more consistent selections each week. Given that they are generally the last team selected for Saturday's, they are sometimes left with last minute calls for players. However, it has been fantastic to see the group grow and to watch as they enjoy their games. While outcomes often don't go their way, cricket is always the winner, along with team spirit and friendship. The team finished 10th in their grade this season.

Our only closed shop Saturday team, the One Day 3B Lions, are a mixture of players from several teams that have played at the club previously. They reformed this season, starting in the 4A grade and winning promotion to 3B for the second half of the season. There are some very good players in this side, and after finishing 6<sup>th</sup> this summer, we will likely see them move further up the grades in future seasons.

The HPCC President's squad continues to grow in both size and quality, as new players look to join the club. They may be considered the older statesman of the game, but they certainly don't play like it as we saw some very exciting games, and strong individual performances. The team finished 5<sup>th</sup> in the grade, with four centuries scored within the squad and three players taking five-wicket bags.

On Sunday's the club fielded three T20 sides, two that played the full season and one that only played half. Competing in the Central East competition, all three teams played some very good games with the HFB XI winning the post-Xmas competition and the Lay Low XI finishing 4<sup>th</sup>.

Our Monday night Twilight continued with 12 teams competing in both the pre and post-Xmas competitions. As always, a massive thanks to David McCullough who volunteers his time to get this all organised, and congratulations to those teams who picked up the coveted Tars head trophy and new Antler Shield (kindly donated by the Smash Hits team) as winners of each competition.





#### 4.4 Junior and Youth Cricket

It was another very successful summer for players and coaches across our junior and youth sides, both boys and girls from U10 – U19.

While most cricket clubs in Auckland noted an early season drop in playing numbers, HPCC showed increases in all our junior and youth grades. We continue to have very strong retention of players across these levels, which highlights our focus on ensuring positive playing experiences. While we love to see our teams win, we also need to factor in the wider reasons why young players participate in our game. As such, ensuring we can provide opportunities for all players is a key part of our club philosophies for these grades.

These philosophies are underpinned in our development of players and volunteer coaches. Our academy coaches are trained to ensure they provide the best support for all involved, and we were delighted to have Adam Jones rejoin the club to lead this as our Academy Development Manager. Both during the off season and within the season we ran programmes to build player skills and provide training opportunities for our coaches.

Our volunteer coaches continue to be the most important resource we have at the club. We simply cannot deliver cricket for all our teams without them, and they are the key people who impact player experience. The more we can support these coaches and develop their skills, the more opportunities our players, regardless of skill level or age, will have to enjoy the game. As such, a massive thank you to those coaches for the time and energy they put into the season.



On the field our teams continued to perform well, and while we didn't win any competitions, we were very close in several grades. Notably, with U15 and U17 Summer Series teams falling just one game short of finals, and one of our U15 T20 sides coming second in their January tournament.



For our younger junior sides, U10 – U12, the JT Sparling Series was run in a different format to previous seasons, with games across a weekend rather than the season. The reason for this, being the increasing difficulty for parents to find time for junior sport. The new format proved popular, and we expect to see it remain this way in the future. On the field, one of our U10 sides won their grade, while teams in the U11 and U12's both competed well. The U10 grade is notable for the inclusion of several young players whose parents have played high level cricket and have been long term members of the club.

This season, we also welcomed St Joseph's Cricket Club from Victoria in Australia who toured parts of the North Island and spent several days playing at HPCC. Players from our U15 and U17 teams had the opportunity to test themselves in these games with HPCC coming out on top. St Joseph's tour the region every two years, and we are looking forward to more games against them in the future.

We continue to see growth in our girls' teams and the popularity of the game continues to grow for these players. It is only five years ago that HPCC could only field one junior girls' team and can now field six. Along with Saturday cricket, some of the teams were given the opportunity to play Festival Days against Auckland University and Cornwall, and several of our U16's also got the chance to player Premier Development and Premier Reserve games. Overall, as our numbers grow, so does the talent and skill of these players and the future of women and girls' cricket at the club looks very strong.



Festival Days against other clubs are a fantastic way to give players additional playing opportunities. This was how the JT Sparling Series first started, and while it has morphed into more of a competitive tournament, there is still the need for games that a wider group of players can participate in. While the girls had opportunities to do this, so did the boys with a Festival Day against Grafton. The weather was not kind for these games, initially rained off and rescheduled, but when we did play the cricket was fantastic to watch.

At higher levels, HPCC again dominated selections in the Manukau sides that played in the ACA District Tournaments. The Manukau boys side competed well but again struggled against teams with combined strength from bigger clubs. However, our sides certainly hold their own and put up a strong fight in every game. The U19's finished second in their tournament, while the U17's finished sixth, with both playing a mix of limited overs and T20 games.

With Papatoetoe cricket no longer having a junior girls programme, selection of Manukau U17 and U19 girls' teams proved to be impossible. While HPCC could have fielded two standalone sides, this would have resulted in players being part of a tournament above their skill level. As such, no Manukau girls' sides were entered into this season's tournaments, and the stronger players from HPCC were provided with the opportunity to play for other districts – Central, Western and North Harbour.

The past season was the last time that we will see district cricket played in Auckland. A new regional Talent and Pathway structure run by Auckland Cricket will change the way these tournaments are delivered, centralising coaching and playing opportunities. HPCC has been a strong supporter of this change as it will provide a greater opportunity for our players to be recognised and supported on their journey to representative honours. For the past season, nine of our players represented either Auckland or Northern Districts at age group level, and we will be aiming to see more in the future.



Across the season we maintained close relationships with our local schools and colleges, supporting their cricket programmes and sharing facilities. Our overall aim is to see players returning to the club once they have graduated and based on recent seasons this is proving to be a major success point for the club. We again partnered with ACA to deliver awareness programmes in schools and worked with the HPPA to deliver their tournament at LEP. The planned South-Eastern Zone Intermediate Schools tournament, we unfortunately cancelled due to the weather.

Finally, with another season completed, we say a massive thank you to all the parents and supporters who volunteer their time across the summer to help our young players take the field. Whether coaching, scoring, umpiring, managing, or simply cheering on teams from the boundary, you all play a part in the success of the junior and youth sections of the club, and we are very grateful for your efforts. Most notably, is the positive environments created for our young players, and we know that they appreciate the time given to support their cricket journey.

Furthermore, our season just wouldn't happen without the efforts of our junior and youth grade coordinators, and we thank them for their dedication throughout the season.

## 6.0 Accounting

#### 6.1 Financial Report

The audited accounts confirm an operating deficit for the year of \$10k compared to a surplus of \$63k last year. Total income was \$451k which was \$40k below last year's result of \$491k.

The deficit is a result of the expenditure for flood related renovations sitting in the P+L rather than being recorded within the fixed asset ledger. The reason for this is the increasing burden of depreciation on the EOY financials. Given the club's expenditure on assets in recent years and forecasting for significant maintenance on the facility over the next few seasons, there is a need to see a reduction in the club's annual depreciation costs.

As such, non-cash expenditure for depreciation included in the result was \$53k compared to \$59k last year. During the year the club purchased \$5k of new fixed assets, however the P+L includes \$42k in maintenance and repairs to the facility.

Despite the EOY statements recording an operational loss, the club's cash position increased by \$46k. The positive cashflow was generated from operating activities during the year, with the closing cash position on 31 March 2025 sitting at \$605k compared to \$559k last year.

The increasing costs of operating and maintaining the facility are a concern going forward and strategies need to be in place to off-set these costs. Most notably, the club will need to ensure that the use of the facilities, particularly the pavilion, are maximised across all 12 months of the year. The off-season lease with BBAFC is under review as they face increasing financial uncertainty, and as such bookings for functions and non-member events will need to be a priority.

Furthermore, feedback from within the NZ cricket community, is that income for club's is reducing and placing pressure on how they operate. HPCC remains in a very strong position as we continue to diversify our revenue streams, retain our membership, and have a focused approach to sponsorship and grant funding. Noting though, that grant funding is becoming harder to access given the Auckland Council's "Sinking Lid" policy, which is reducing the overall number of Class Four Poker Machine venues in our area and placing pressure on the funds available for the local community.

Regardless, the club remains committed to ensuring that it continues to be in a positive financial position and is prudent with all costs and expenditure. Existing income streams will remain stable, and new opportunities will be sought to meet the immediate and longer-term needs of the club.

Finally, thank you to all those who contributed to the financial success of the club this season, your ongoing support is always appreciated. Additionally, a massive thank you to our sponsors and grant funders, and to all those who assisted with events and other fundraising initiatives.

#### Scope

### **Basis of Preparation**

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Reporting - Accrual (Not-for-Profit) on the basis that it does not have public accountability and has total annual expenses less than or equal to \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

#### Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

#### Income Tax

Howick Pakuranga Cricket Club Inc. is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

The Club has been granted a not-for-profit status and is recognised as a charitable organisation by the Inland Revenue Department and the Charities Services. As such it is exempt from income tax on income derived for charitable purposes.

### Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

## Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

#### Revenue

Revenue shown in the Statement of Financial Performance comprises the amount received and receivable by the Club for goods and services supplied to members in the ordinary course of the Club activities
